## <u>Subject:</u> Interlocal Agreement with the city of Everett, the Snohomish

Conservation District and Snohomish County for cooperative efforts with

LID and other NPDES Permit related programs and activities.

### Scope:

The County, through its WSU Extension office, and the District agree to provide services to the City regarding information, education and outreach, including technical support on pollution prevention BPs, GSI/LID, and other NPDES permit-related requirements. For each year of the Agreement, the specifics of the Works will be detailed in a Scope of Work and Budget, to be amended each year with a new Exhibit A-Scope

of Work and Budget through 2029.

**Duration:** From execution through December 31, 2029.

Authority Granted: Approve and authorize of the County Executive to sign the Interlocal agreement between the city of Everett, Snohomish County and Snohomish Conservation District regarding National Pollution Discharge Elimination System (NPDES) Programs in the form as attached to the ordinance as Exhibit A. The Council would further authorize the Director of the County's Conservation and Natural Resources Department to approve amendments to the agreement on behalf of the County without the need to obtain additional approval from Council or the Executive.

**Background:** The WSU Extension office has expert knowledge and a trained volunteer force to carry out educational programs, such as rain garden installation and natural yard care. The city of Everett desires to work with Snohomish County through the WSU Extension office and the Snohomish Conservation District to provide education and outreach on NPDES permit-related requirements. The parties wish to enter into an Agreement to provide for the administration of the project, pursuant to the Interlocal Cooperation Act, RCW 39.34.
