### **SOLUTIONS OVERVIEW**

Siemens Industry, Inc. (SI) is pleased to provide the following proposal for the above referenced project. This quote is based upon the installation of new readers requested by Snohomish County for the Siemens Project ID 44OP-240571 Snohomish County Courthouse Lobby Security Modifications. This request will be an add to the existing base contract.

#### **Optical Lanes**

Siemens has been requested to add horn strobes to the optical exit lanes located in the new courthouse lobby. The horn strobes will be configured to annunciate when a person tries to enter the lobby thru the exit lanes. Siemens will add two (2) key switches at the sheriff's desk to allow the lanes to be placed in a bypass mode which will shunt the horn strobes from going into alarm. The key switches will be configured to accept a Snohomish County cylinder and core. Siemens will provide and install cabling through existing conduit pathways and risers. If the pathways do not exist, additional project change request will be provided to create the pathway from the optical lanes to the sheriff's desk. Security cabling will be installed to the basement level SiPass security enclosure located directly below the optical lanes.

#### **CR.9-7 Stairwell Employee Exit**

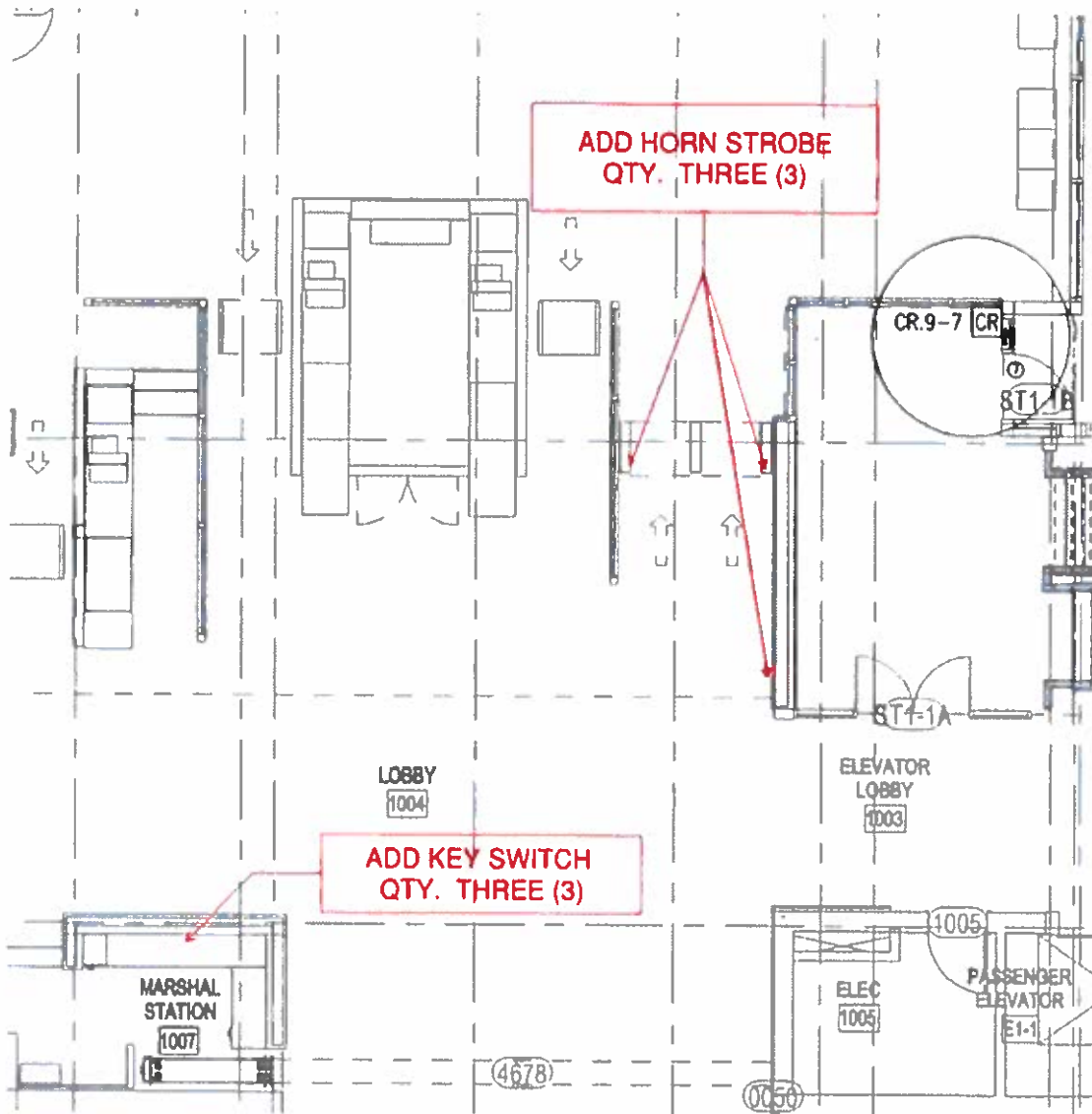
Siemens will add a horn strobe in the lobby for CR.9-7 Employee Exit. This will allow the on-duty officers to know when the exit door is in alarm. The current door alarm annunciator is not loud enough for the officers to hear. The sheriff's desk will be equipped with one (1) key switch to reset the horn strobe if it goes into alarm. The key switch will be configured to accept a Snohomish County cylinder and core. Security cabling will be installed to the basement level SiPass security enclosure located directly below the optical lanes.

#### **SiPass Client Software**

Siemens will also add the SiPass client software to a Snohomish County provided workstation at the sheriff desk and at Sgt. Matthew Onderbreke's laptop. The workstations must meet the software recommended requirements.
