PROPOSED ORDINANCE NO. 25-003

AUTHORIZING THE SNOHOMISH COUNTY EXECUTIVE TO SIGN
ON BEHALF OF SNOHOMISH COUNTY AN INTERLOCAL AGREEMENT
BETWEEN SNOHOMISH COUNTY AND THE CITY OF EVERETT FOR
SPECIAL ASSESSMENT COLLECTION SERVICES

Background: The ordinance authorizes the Snohomish County Executive to sign on behalf of Snohomish County an Interlocal Agreement between Snohomish County and the City of Everett (City) for special assessment collection services. The City has adopted the necessary legislation to authorize entering into an agreement and to levy a special assessment under RCW 35.21.955. The City now desires to have the County bill and collect special assessments on their behalf. The City shall reimburse the County its reasonable costs and expenses incurred by the County for the billing and collection of special assessments. Consistent with RCW 84.56.035, the service fee is 1% of the special assessments collected, with this fee being deducted from each monthly payment to the City of collected special assessments. The term of the agreement is from execution through December 31, 2026.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
