NOTICE IS HEREBY GIVEN, that on December 3, 2025, the Snohomish County Council approved Ordinance 25-073.

## ORDINANCE NO. 25-073

GRANTING A NONEXCLUSIVE CABLE FRANCHISE AUTHORIZING LIMITED USE OF THE PUBLIC ROAD RIGHTS-OF-WAY IN SNOHOMISH COUNTY, WASHINGTON TO WAVEDIVISION I, LLC D/B/A ASTOUND BROADBAND

Wavedivision I, LLC D/B/A Astound Broadband has applied to Snohomish County, Washington, for a non-exclusive franchise to construct and operate a Cable System in, along, among, upon, across, above, over, under, or in any manner connected with Public Rights-of-Way within the Franchise Area, and for that purpose to erect, extend, install, connect, construct, repair, remove, replace, reconstruct, maintain, or retain in, on, over, under, upon, across, or along any Public Rights-of-Way and all extensions thereof and additions thereto, such poles, wires, cables, conductors, ducts, conduits, vaults, manholes, pedestals, amplifiers, appliances, attachments, and other related property or equipment that constitute the Cable System, and as may be necessary or appurtenant to the Cable System within all County rights-of-way in unincorporated areas of Snohomish County.

Ordinance No. 25-073 grants said franchise to Wavedivision I, LLC D/B/A Astound Broadband, subject to all of the terms and conditions contained in the ordinance. The franchise would go into effect following enactment of the ordinance, acceptance by Wavedivision I, LLC D/B/A Astound Broadband, provision of evidence of insurance, and payment of all applicable fees. The maximum term of the franchise would be ten (10) years from the effective date.
