Vulnerability assessments provide information like economic damage estimates in the event of catastrophic flooding. This information can be used to influence decision-making about a variety of capital and policy actions at the County. SWM plans to use the information to help sequence capital projects in our floodplains to ensure that we are making the best investments of public dollars in the most appropriate places. Although the specific amount of savings is hard to measure currently, we will have better estimate on those potential savings following the assessment work. The information from the assessment can also be used to inform grant applications for County projects and programs.
