<u>Subject:</u> Health Communication Agreements for the Community Navigator

Program

Scope:

Snohomish County, acting though its Health Department, was awarded the U.S. Department of Health & Human Services (HHS) Office of Immunization COVID-19 Vaccine Community Navigator Program grant. The Health Department is seeking to contract with North Counties Family Services, The Clearwater School, Washington West African Center, Nashi Immigrants Health Board, Volunteers of America Western Washington, and the Center for Human Services for Community Navigator services.

Under the terms of the contracts, service providers will employ Community Navigators to disseminate public health information in a culturally relevant format to marginalized communities and communities with the lowest COVID-19 vaccination rates in Snohomish County. Community Navigators will:

- Assist with scheduling vaccination appointments,
- Facilitate community meetings and promote public health initiatives,
- Distribute culturally appropriate public health information to the community that will be developed collaboratively between Health Department staff and the service provider, and
- Assist with collecting data on community health indicators.

<u>Authority Granted:</u> Motions 25-146, 25-159, 25-160, 25-163, 25-166, and 25-167 authorize the Executive to sign agreements for the community navigator program.

Background: On February 26, 2025, the County Council passed Motion 25-091¹, authorizing the Executive to sign an agreement with Latino Educational Training Institute for a Community Navigator Program in the amount not to exceed \$62,700.

On March 12, 2025, Council approved Motions 25-126 (with Project Girl Mentoring), 25-127 (with the Marshallese Association), 25-128 (with the Korean Community Service Center), and 25-129 (with Oceania Northwest) authorizing the Executive to sign agreements for the community navigator program.
