Subject: Project Award – HOME-ARP Funding – YWCA Emergency Shelter

Scope: Approve the award of \$1,099,998.90 in HOME-ARP funding for the YWCA Emergency Shelter, Homeward Bound Emergency Shelter in Lynwood.

Background: The US Department of Housing and Urban Development requires Snohomish County adopt the Snohomish County Urban County Consortium's annual action plan (Plan) to receive federal grant funds under the [Community Development Block Grant \(CDBG\)](#), [HOME Investment Partnerships \(HOME\)](#), and [Emergency Solutions Grant \(ESG\)](#) programs.

These grant funds are used for affordable housing, facilities providing community services, infrastructure projects, homeless programs, and economic development activities and must primarily benefit low-income individuals. Snohomish County is the lead agency for the Consortium. Projects using these funds are reviewed and recommended by both the Technical Advisory Committee (TAC) and Policy Advisory Board (PAB), after which they are forwarded to Council for approval of the project awards.

To address the need for homelessness assistance and supportive services, Congress appropriated \$5 billion, of which the County received roughly \$7 million, in ARP funds to be administered through HOME-ARP to perform activities that must primarily benefit qualifying individuals and families who are homeless, at risk of homelessness, or other vulnerable populations.

On March 22, 2023, Council passed Motion [23-111](#) approving the HOME-ARP Allocation Plan as a substantial amendment to the Snohomish County Urban County Consortium's [2021 Annual Action Plan](#). The amendment allocated \$6,200,821 for enhanced services at non-congregate or other shelters (bridge housing) and \$1,094,262 for planning and administrative costs.
