23 24 25 26	WHEREAS, the limit factor for taxing jurisdictions with a population of 10,000 or greater is the lesser of 101% or 100% plus inflation, which, as of September 25, 2025, has been determined to be more than 101% for 2026; and
27 28 29 30	WHEREAS, the County Council has determined that there is a need for an increase in the 2026 general property tax levy within the limitations imposed by chapter 84.55 RCW as authorized by separate ordinance pursuant to RCW 84.55.120; and
