**AMENDMENT NO.1 TO CONTRACT FOR LEGAL SERVICES
CONTRACT NO. CC02-19**

THIS AMENDMENT NO. 1 to that certain Contract for Legal Services Contract No. CC02-19 dated January 3, 2019, (the "Agreement") is entered into by and between Snohomish County, (hereinafter referred to as COUNTY), and Joyce Ziker Parkinson, PLLC (hereinafter referred to as ATTORNEY).

In consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the COUNTY and ATTORNEY agree that the Agreement shall be amended as follows:

Paragraph VI, Compensation, Section 1 is hereby amended to read:

1. From Execution until April 30, 2019, County shall pay ATTORNEY for legal services provided under this AGREEMENT at the following hourly rate for legal services actually provided: William F. Joyce, three hundred seventy-five dollars (\$375.00). In the event that Mr. Joyce delegates work to an associate under Article IV of this AGREEMENT, COUNTY shall pay for their services the following hourly rate: three hundred dollars (\$300.00). In the event that Mr. Joyce delegates work to a paralegal/legal assistant under Article IV of this AGREEMENT, COUNTY shall pay for their services at the following hourly rate: one hundred ten dollars (\$110.00).

From May 1, 2019, through December 31, 2019, County shall pay ATTORNEY for legal services provided under this AGREEMENT at the following hourly rate for legal services actually provided: William F. Joyce, three hundred eighty-five dollars (\$385.00). In the event that Mr. Joyce delegates work to an associate under Article IV of this AGREEMENT, COUNTY shall pay for their services the following hourly rate: three hundred twenty-five dollars (\$325.00). In the event that Mr. Joyce delegates work to a paralegal/legal assistant under Article IV of this AGREEMENT, COUNTY shall pay for their services at the following hourly rate: one hundred twenty-five dollars (\$125.00).

All other terms and provisions of the Agreement shall remain in effect.
