Is it your expectation that there will be no drug use at those facilities and no further decontamination will be required? At what point does the Housing First Plan require no-barrier housing to be tested and decontaminated?

The point is, decontamination of the facility is inevitable. Experience tells us that the longer you leave something undone, the more effort it takes to clean it up.
