APPROVING AMENDMENT TO WHATCOM COUNTY CONTRACT FOR YOUTH
CANNABIS & COMMERCIAL TOBACCO PREVENTION PROGRAM

Summary: The ordinance approves the agreement amendment with Whatcom County Health Department to coordinate implementation of strategies aimed at reducing initiation and use of cannabis and commercial tobacco by youth (ages 12-20) in the North Sound Region. The purpose of this agreement is to support the Snohomish County Health Departments' participation in planning and implementing youth cannabis and commercial tobacco prevention strategies and activities. The amendment increases funding by \$45,000 and extends the contract period until June 30, 2024.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
