1. [Ordinance 21-106/2021-1085](#) Relating to Growth Management; amending development regulations in Chapters 30.24 and 30.41 SCC pertaining to Roads and Access
 - a. This was introduced by Councilmember Nehring on December 20, 2021
 - b. This ordinance will be scheduled for public hearing on February 23, 2022, and needs to be re-introduced by February 1st.
 - c. Please provide me with Councilmember Nehring's or another councilmember's written authorization for re-introduction via e-mail and I will affix their electronic signature to the existing introduction slip.

2.48.175 Lapse and reintroduction of ordinances.

A proposed ordinance that is not passed by the council by the end of the calendar year in which it is introduced lapses if not reintroduced, passed, or defeated by February 1 of the following year. A proposed ordinance is reintroduced upon filing with the clerk of the council with the signature of at least one council member on a reintroduction form approved by the clerk. A proposed ordinance that is reintroduced retains the number originally assigned by the clerk. (Last updated May 17, 2011)
