WHEREAS, Kaplan Kirsch & Rockwell LLP has provided the County with sound legal advice regarding federal aviation and airport law and airline requests for commercial passenger service at the Snohomish County Airport at Paine Field; and

WHEREAS, the Kaplan Kirsch & Rockwell firm has been counsel to a wide variety of public agencies and private clients around the country concerning cutting-edge federal aviation law, regulation and compliance issues; and



AMENDMENT NO. 1 TO AGREEMENT FOR LEGAL SERVICES
WITH KAPLAN KIRSCH ROCKWELL LLP

This Amendment No. 1 to the Agreement for Legal Services (the "Agreement") is entered into this 29th day of September 2021, by and between SNOHOMISH COUNTY, a political subdivision of the State of Washington (the "County"), and KAPLAN KIRSCH & ROCKWELL LLP Attorneys at Law (the "Attorney").

Section 1. Compensation. Section 3.a. of the Agreement is revised to add the following term:

- a. The total charges for services and other matters provided by the Attorney under this Agreement during the term of this Agreement is increased by \$50,000 (Fifty Thousand Dollars) which shall not be exceeded without prior written authorization of the County.

Section 2. No Other Modification. All terms conditions and provisions of the Agreement shall remain in full force and effect except as expressly modified by this Amendment No. 1.
