**MOTION NO. 00 - 109**

**AMENDMENT TO MOTION 98-103  
AUTHORIZING THE SALE OF SURPLUS PROPERTY  
AND AMENDING THE REVENUE FUND CODES  
FOR DEPOSIT OF SALE PROCEEDS**

**WHEREAS**, the Snohomish County Public Works Department and the Property Management Division recommend that ten (10) properties be declared surplus to the Counties needs; and

**WHEREAS**, Environmental Risk Assessments will be completed on all the sites before the sale; and

**WHEREAS**, the property tax account numbers, approximate acreage's and legal descriptions of the properties are legally described on the attached "Exhibit A"; and

**WHEREAS**, the properties have not been surveyed; and

**WHEREAS**, a minimum bid for each parcel will be established by current comparable sales and/or appraisals; and

**WHEREAS**, the SCC 4.46.170 and 260 allows the County to sell directly to a government agency or to sell at public auction; and

**WHEREAS**, the Snohomish County Council, the Department of Public Works and the Property Management Division consider it in the best public interest to surplus the above described properties; and

**WHEREAS**, Motion 98-103 authorized the sale of the properties; and

**WHEREAS**, the revenue fund accounts in Motion 98-103 were incorrectly stated on the Motion; and

**WHEREAS**, this amendment is to clarify the appropriate revenue fund codes for the deposit of proceeds for the sale of these properties; and

**WHEREAS**, the proceeds from the sale of the properties shall be deposited into the Facilities Construction fund (DAC 1883066159510) or the Pits and Quarries fund (DAC 5073068289510) as stated in Exhibit A.

**NOW, THEREFORE, ON MOTION**; the Snohomish County Council authorizes the surplus and sale of the properties legally described on the attached "Exhibit A" and authorizes the proceeds to be deposited into the Facilities Construction fund (DAC 1883066159510) or the Pits and Quarries fund (DAC 5073068289510) and authorizes the Executive to sign the deeds when issued.
