<u>Authority Granted:</u> Approves and authorizes the County Executive to sign Amendment No. 3 with CORT Business Services Corporation for the 2025 Evergreen State Fair, in an amount not to exceed \$65,000.00, under SCC 3.04.140(11).

<u>Background:</u> The County issued RFP 010-21DW for canopy, decorator, display booth rentals and support services at the Evergreen State Fairgrounds. Cort Business Services Corporation d/b/a as CORT Party Rentals was selected following all Federal, State and County policy and procedures. Snohomish County signed the original five-year contract in July 2021 to provide services for the 2021, 2022, 2023, 2024 and 2025 annual Fair.

Amendment 1 was signed in October 2021 for larger tents at an increased amount of \$11,000 to allow for social distancing.

Amendment 2 was signed in November 2024 for additional equipment (canopies, drapes and poles) for an increase to the rental cost for a new not to exceed maximum amount of \$50,000 for the 2024 and 2025 annual Fair.

Amendment 3 would allow for additional rental costs including set-up/take-down and support services for additional canopies and equipment to provide additional cover for public seating, dining and a judging ring.
