

**SNOHOMISH COUNTY DEVELOPMENTAL DISABILITIES CITIZEN ADVISORY BOARD**

SCC 2.400.030 authorizes the Human Services Department to administer and coordinate county programs and projects relating to human services in accordance with county, state and federal laws or regulations. DSHS, through its division of developmental disabilities, has a program to provide child development services, community access services, individual supported employment, grant-supported employment, and specialized industries employment. Board is made up of up to 15 members, who serve three-year terms and may not serve more than three consecutive terms without two years leave.
