**Subject:** Amendment No. 1 to the agreement for Access to Baby Child Dentistry

**Scope:** The Snohomish County Health Department has a contract with Washington State Department of Health to provide “Access to Baby and Child Dentistry” (ABCD) services to detect and prevent early childhood dental decay by engaging dentists in seeing eligible Apple Health/Medicaid clients. Snohomish County is required to:

- Conduct outreach to clients.
- Provide orientations to families about the value and importance of oral healthcare.
- Connect patients to an ABCD certified dentist.
- Coordinate ABCD dentist recruitment.
- Plan and implement, in coordination with the UW School of Dentistry, timely ABCD provider trainings.

Amendment No. 1 to the agreement increases the contract amount by \$62,000, bringing the contract total to \$212,576.

Additionally, the amendment revises the definition of client from “an individual who is eligible for or receiving services through HCA program(s)” and “Medicaid eligible Clients ages birth through six (6) years of age.” The new definition is “Medicaid eligible Clients ages birth to six (6) years of age and ages six (6) to thirteen (13) who are clients of Developmental Disabilities Administration.”
