BE IT ORDAINED:

Section 1. The County Council makes the following findings of fact: an emergency appropriation in Special Revenue Fund 100, for the 2023 budget year, in the amount of \$552,776, is necessary to provide expenditure authority for emergency courthouse technology upgrades and improvements.

Section 2. The appropriation units and allocation details for the emergency appropriation described in Section 1 are as follows:




