BRIEF DESCRIPTION:

The Purchasing Division requests the use of a “piggyback” or “cooperative purchase” under SCC 3.04.220 utilizing a competitive bid issued and awarded by the Office of Washington State Department of Enterprise Services (DES). A Contract Usage Agreement between Snohomish County and DES authorizing cooperative purchases was approved by the County Council under Motion 24-232 and is currently in effect.

DES, through cooperation with NASPO, has negotiated and agreed to Participating Addenda No. 07425 for Passenger Vehicle and Box Truck Rentals on January 31, 2025. Each Participating Addendum references Master Agreements by and between the State of Oregon on behalf of member states of the NASPO ValuePoint Cooperative Purchasing Program with the suppliers listed below:

The Master Agreements have an initial term ending 8/1/2026 with an ultimate term ending 8/1/2030 and are the result of State of Oregon RFP No. S-10700-00011242. This request is to make available rental services to all departments and offices county-wide. The estimated award amount is \$150,000 over five years.

AWARD AUTHORITY:

This contract award recommendation is before the County Council for approval to award in accordance with Snohomish County Code section 3.04.120, “Formal sealed bidding,” and Section 3.04.140(11) “Award, execution, by whom,” which establish the County Council as the award authority for contracts for services greater than \$50,000. The County Council approves this Award and authorizes the County Executive or designee to execute Agreements for the products and/or services as defined.
