#### In 200 words or fewer, please describe your top priorities for the 44<sup>th</sup> Legislative District.

# In 200 words or fewer, please describe your position for adopting policies that must be implemented on a local level without funding from the State, i.e. unfunded state mandates.

As far as 'unfunded mandates,' much comes down to the specifics. It could be:

- Something new that the state wants local governments to do.
- Added onto something existing the local governments are already receiving state money for.
- Something that is partially funded by the state.
- A revision to an existing requirement.
- Something that another body should be doing, but isn't.
- Enforcement requirements for an existing statute that's not being enforced.
- A cost which would vary greatly by locality
- A mix or something else entirely.

All of these could require different answers, and even have different answers depending on the specifics.

In general, I'm opposed to unfunded mandates unless the costs being incurred are due to correcting the inappropriate policies and/or actions (or inactions) of the body it applies to. Generally, if it worth doing, part of that means paying for it.

There is a flip side to this though. Snohomish County is one of the few in the state that contributes more to the state coffers than it receives back. In effect, we're helping to fund the state-funded mandates in other counties. Any state-funded mandates need to be considered from that aspect as well.

Ultimately though, it's the details.

## In 200 words or fewer, please describe how you would work collaboratively with both parties in Olympia?

For me, it's a matter of working with people who interested in working through differing solutions based on facts, evidence, and fairness. Members of both parties can falter on all three of these at times. I can as well. But anyone who makes an honest effort in these areas, I can work with.

A big piece of this is being open-minded and able to examine your own opinions and concede the possibility that you might not have the best solution to the problem. That the solutions need to be evaluated on their merits, the facts, and the evidence, not on what you want to be the best solution. I try to follow the mantra that it doesn't have to be my solution to be a good one – a good solution is a good solution.

There's also the aspect of being realistic. Not everyone will agree on the answer to a problem. The ideal solution may not be able to get sufficient support to pass. An ideal solution that stands no chance of getting approved is not near as good as a partial one that can.

Ultimately though, working together is about listening, considering, discussing, and being realistic.

# The response to reduce the rate of spread of the COVID-19 virus resulted in significant impacts to our economy. In 200 words or fewer, please describe the steps you plan to take to mitigate these impacts on private employers, residents and state/local government.

How different entities (individuals, businesses, and government entities) have dealt with COVID-19 is an issue that touches myself and my family, as well as a great many others very directly.
