BE IT ORDAINED:

Section 1. Snohomish County Code Section 4.122.050, adopted by Ordinance No. 19-062 on October 14, 2019, is amended to read:

The moneys collected under this chapter shall only be used for the ((following)) purposes((:)) allowed under RCW 82.14.540.

~~((1) Acquiring, rehabilitating, or constructing affordable housing, which may include new units of affordable housing within an existing structure or facilities providing supportive housing services under RCW 71.24.385; or~~

~~(2) Funding the operations and maintenance costs of new units of affordable or supportive housing.))~~

At the Public Hearing, the Council may consider amendments to the proposed ordinance.


