2. Ordinance 22-026, granting a non-exclusive franchise authorizing [2022-0564](#) limited use of the public road rights-of-way in Snohomish County, Washington to Comcast Cable Communications, LLC and Comcast Cable Communications Management, LLC, jointly and severally

Acting Council Chair Mead opened the hearing and the clerk read the ordinance title into the record.

Deb Bell, Senior Legislative Analyst, provided an overview of the scope of the franchise agreement. She also highlighted that Comcast also agrees to provide support for implementation of Educational and Governmental Access Channels as outlined in the 2021 Cable Needs Assessment Report.
