Exhibit A details 11 changes to precincts due to growth in the 19 number of voters in a precinct and 2 changes to precincts due to city annexations; 20 21 NOW, THEREFORE, BE IT ORDAINED: 22 23 Section 1. The Council finds that pursuant to the authority of SCC 2.47.040(2), the Auditor 24 made those adjustments to precinct boundaries since April 12, 2023, that are set forth in 25 Exhibit A, attached hereto and incorporated herein by this reference. 26 27 Section 2. Snohomish County Code Section 2.47.030, last amended by Ordinance 23-021 28 on April 12, 2023, is amended to read: 29 30 2.47.030 Precincts adopted. 31 32 (1) The adopted voting precinct boundaries for the county are those set forth in 33 the precinct map books maintained on file with the clerk of the council and the 34 Snohomish County auditor's office, subject to revision from time to time in accordance 35 with SCC 2.47.040. 37 (2) To implement boundary changes resulting from redistricting following the 38




