PROPOSED ORDINANCE NO. 22-015

RELATING TO THE SUPERIOR COURT, INCREASING THE NUMBER OF SUPERIOR COURT COMMISSIONERS, AND AMENDING CHAPTER 2.14 SCC

Section 1. Snohomish County Code Section 2.14.010, last amended by Ordinance 05-044 on June 29, 2005, is amended to read:

2.14.010 Creation of ((Position)) Positions.

- (1) Pursuant to Washington Constitution, Article IV, Section 23, there is created within the superior court of Snohomish county three positions of court commissioner.
- (2) Pursuant to RCW 26.12.050, ((and))71.05.135, and 10.14.045 there is created within the superior court of Snohomish county ((two)) three positions of family court/ mental health/protection order commissioner.

At the hearing, Council may consider alternatives/amendments to the proposed ordinance.
