(1) Name Calling

Links person to negative symbol in hopes that the audience will reject the person or idea on the basis of that negative symbol; no evidence.

(2) Card Stacking

Use of statistics, often one sided manner. It is biased because it leaves out important information that is crucial to drawing an informed conclusion.

(3) Glittering Generalities

Name calling in reverse, seeks to make us approve and accept without examining evidence.

(4) Plain Folks

Appeals to regular people.

(5) Bandwagon

Tries to convince audience that everyone else is doing it so they should too.

Transfer

(6) Projecting positive or negative qualities onto a person to make the other seem more acceptable or discredit them.

(7) Fear

Disaster will result if the audience doesn't follow a particular course of action.

In 2009 I noticed an article in Readers Digest on screening tests. What got my attention was the article was written in super market tabloid style. It was laced with sensational statements and horror stories about medical test and procedures gone wrong. It was obvious a planted story. One doctor's name appeared several times in this story, Dr. Gilbert Welsh. I assumed that Dr. Welsh and his associates were the ones that had planted the story. I kept seeing these stories in the printed media, Newspapers, magazines, books and etc. The Consumer Reports printed a story on screening tests. DR. Welsh's name appeared as a consultant for the story, but also THE AMERICAN BOARD of INTERNAL MEDICINE's Choose wisely campaign was given as the source for the information contained in the article.

These were planted stories that contained all 7 of the elements of propaganda.
