#### ORDINANCE NO. 23-059

GRANTING A NON-EXCLUSIVE TELECOMMUNICATIONS FRANCHISE AUTHORIZING LIMITED USE OF THE PUBLIC ROAD RIGHTS-OF-WAY IN SNOHOMISH COUNTY, WASHINGTON TO ZIPLY FIBER NORTHWEST, LLC D/B/A ZIPLY FIBER

Ziply Fiber, has applied to Snohomish County, Washington, for a non-exclusive franchise to construct, maintain, operate, replace and repair telecommunication systems in, on, across, over, along, under, and/or through public rights-of-way within the boundaries of unincorporated Snohomish County.

Ordinance No. 23-059 grants said franchise to Ziply Fiber, subject to all of the terms and conditions contained in the ordinance.

The franchise would go into effect following enactment of the ordinance, acceptance by Ziply Fiber, provision of evidence of insurance, and payment of all applicable fees. The maximum term of the franchise would be twenty (20) years from the effective date.
