Element 6.0 Final Design Plans, Special Provisions, and Estimates (PS&E)

6.4 100% Submittal

The 36th-35th Ave W Improvements project was originally contracted in 2008. The process of computerized corridor modeling, side street tie-ins, driveways, and drainage systems have all been refined over the duration of the project. Civil3D was not an established software when the Project's original corridor modeling was created. The legacy nature of the model has created issues with pulling accurate station-based quantities, particularly cut and fill quantities that are desired by the AGENCY for construction review and monitoring.

As part of the AGENCY's comments and review of the existing corridor modeling based on the plans vs. desired work outcome, it was identified that the corridor model will need to be revised and/or rebuilt to properly break out quantities by station ranges for revised bid schedules that reflect the changes to grading, HMA depths (overlay, full-depth, edge grind, etc.), drainage, driveways, and ADA compliant curb ramps. The CONSULTANT first rebuilt the previously completed model with current modeling techniques to allow for updated quantity determination. Additionally, the AGENCY's comments wanted to eliminate an in-road grade break between the existing roadway slope and proposed new sections of roadway by altering the final paving. During this design phase, the AGENCY had the CONSULTANT revise the recently updated corridor modeling to properly reflect the planning and overlay with 2% cross slope (without grade break within the travel lane) for the length of the 36th-35th corridor. This will provide the desired project outcome (smooth overlay without grade breaks) and continuity between the corridor model, plan sheets, and quantities.

As part of the model update, a number of project plan disciplines will require updates due to elevation changes from within the corridor model. These updates require a partial or full redesign of these project elements prior to the 100% submittal deliverable. The CONSULTANT shall update and validate the designs and calculations for the following project plan set disciplines, based on the updated corridor modeling.

- Typical Roadway Sections
- Roadway Plan and Profiles
- Curb Ramp Plans
- Drainage Plan and Profiles
- Driveway Plan/Profile/Details
- Retaining Wall Plan/Profile/Details

The CONSULTANT 100% deliverable package shall include completed and updated drawings, quantities, and Engineer's estimate/SOQ for the PROJECT based on the revisions/additions identified above.
