NOTICE OF ENACTMENT

NOTICE IS HEREBY GIVEN, that on June 15, 2022, the Snohomish County Council approved Amended Ordinance 22-022, which shall be effective on July 3, 2022. A summary is as follows:

AMENDED ORDINANCE NO. 22-022

AMENDING THE DATE AND TIME OF REGULAR AND STANDING MEETINGS OF THE  
SNOHOMISH COUNTY COUNCIL IN CHAPTER 2.48 SNOHOMISH COUNTY CODE

Section 1. SCC Section 2.48.020 is amended to change Monday regular council meetings to Tuesdays.

Section 2. SCC Section 2.48.110 is amended requiring the clerk to post and deliver regular meeting agendas no later than 4:00 p.m. on the work day preceding each regular council meeting other than a council committee meeting. The section also reflects the change of administrative session from Monday to Tuesday.

Section 3. SCC Sections 2.48.122 is amended to reflect the change of administrative session from Monday to Tuesday.

Section 4. SCC Section 2.48.123 is amended to reflect the change of administrative session from Monday to Tuesday.

Section 5. SCC Section 2.48.170 is amended to establish standing committee meeting times on Tuesdays:

(a) Finance and economic development – ~~((second and fourth Tuesday at 10:30 a.m.))~~  
second and fourth Tuesday at 10:00 a.m.;

(b) Law and justice/human services – ~~((second and fourth Monday at 1:30 p.m.))~~ second and fourth Tuesday at 1:00 p.m.;

(c) Conservation, sustainability and recreation – ~~((second and fourth Tuesday at 9:00 a.m.))~~  
second and fourth Tuesday at 11:00 a.m.;

(d) Planning and community development – ~~((first and third Tuesday at 10:30 a.m.))~~ first and third Tuesday at 11:00 a.m.;

(e) Public works and infrastructure – ~~((first and third Tuesday at 9:00 a.m.))~~ first and third Tuesday at 10:00 a.m.
