AGREEMENT FOR PROFESSIONAL SERVICES – AMENDMENT NO. 3

THIS AMENDMENT NO. 3 to that certain Agreement for Professional Services (the “Agreement”) dated August 16, 2021, is made by and between Snohomish County, a political subdivision of the State of Washington (the “County”) and McKinstry Company, a Washington corporation (the “Contractor”).

NOW, THEREFORE, for and in consideration of the benefits conferred on both parties and the mutual promises set forth below, the parties agree that the Agreement be amended as follows:

1. An oversight was identified regarding an overspend on the Cathcart Gun Range HVAC Maintenance contract with McKinstry Company on RFP-019-21DW and this Amendment 3 is intended to correct the oversight and future spends.
1. The original contract amount of \$205,164, plus Amendments 1 & 2 added \$6,895 for a total of \$212,059 authorized to date. Amendment 3 adds the funding needed to correct the overspend and adds funding through 8/15/2024 for additional funding total of \$300,000.00 and to complete the contract through end date of 8/15/2026 which will be processed on Amendment 4 just following this amendment. The new contract NTE is \$512,059 for Cathcart Gun Range HVAC Maintenance.
