AUTHORIZING EXECUTION OF PUGET SOUND ENERGY RIGHT OF ENTRY PERMIT AND PRIVATE OWNERS RIGHT OF ENTRY AGREEMENTS TO ALLOW SNOHOMISH COUNTY'S CONSULTANTS TO ENTER AND CONDUCT LAND AND ENVIRONMENTAL SURVEYS WITHIN THE SNOHOMISH RIVER REGIONAL TRAIL PROJECT AREA

WHEREAS; on July 17, 2019, by Motion 19-193, the County Council approved the expenditure of up to \$250,000.00 of Conservation Futures funds to acquire the Puget Sound Energy property in fee title ownership. The purpose of this acquisition was for future development of a Regional Trail connection from east of Airport Way south of the City of Snohomish to the City of Everett; and

WHEREAS; Snohomish County is in the process of conducting land and environmental studies associated with developing the regional trail, to help determine the best route alignment options; and

WHEREAS, there are properties within the proposed trail area that are owned by Puget Sound Energy (PSE) and private owners that require surveying and permission for County Consultants on behalf of the County, to enter and survey sections within the regional trail area;

NOW, THEREFORE, ON MOTION, the Snohomish County Council approves the following:

<u>Section 1.</u> The County Council approves the Puget Sound Energy Right of Entry Permit in the form included herein and authorizes the County Executive or the Property Officer of Facilities Management to execute the Puget Sound Energy Right of Entry Permit, on behalf of the County.

<u>Section 2</u>. The County Council approves the Private Property Owner Right of Entry Agreements in the substantial form included herein and authorizes the County Executive or the Property Officer of Facilities Management to execute the Private Property Owner Right of Entry Agreements, on behalf of the County.

<u>Section 3</u>. The County Council approves and authorizes the County Executive or the Property Officer of Facilities Management to take all actions consistent with the Private Property Owner Right of Entry Agreements that are reasonably necessary to complete the surveys necessary to determine the best route alignment options.
