### BRIEF DESCRIPTION:

A competitive Invitation to Bid was issued to solicit pricing for demolition and clearing; earthwork; construction of a multispan, BNSF Railway (BNSF) railroad bridge and associated embankment modifications, and fencing; geotechnical reinforcement and repaving of an access road; concrete and asphalt and crushed rock paving for park pathways; restoration of an estuarine tidal marsh, stream, and riparian areas; construction of a restroom enclosure; replacement of a picnic shelter roof; installation of a pre-fabricated pedestrian bridge, construction of pedestrian bridge abutments and guardrails; boardwalk construction; installation of site furnishings, a new irrigation system, landscape topsoils, erosion control fabrics, and planting; and improvements to utilities, including water service, storm drainage, and electrical, including lighting

This project is subject to Snohomish County Apprenticeship utilization goal of 15% of total project labor hours.


