

AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT
BETWEEN SNOHOMISH COUNTY AND WESTERN GRAPHICS, INC.
FOR VEHICLE GRAPHICS

This Amendment No. 1 to the Professional Services agreement between Snohomish County and Western Graphics, Inc. ("Amendment No. 1"), is entered into by and between Snohomish County, a political subdivision of the State of Washington (the "County"), and the Western Graphics, Inc. a Washington corporation, (the "Contractor").

WHEREAS, March 2, 2023, the County and the Contractor entered into a Professional Services Agreement for Vehicle Graphics ("Agreement"). The Agreement governs the professional services provided by Contractor from December 1, 2022, to November 30, 2024; and

WHEREAS the Agreement allows the parties to extend the Agreement for two additional two year terms.

WHEREAS the Parties desire memorialize their agreement to extending the Agreement for the first additional two year term, updating pricing, and providing funding to support the additional work.

NOW THEREFORE, in consideration of covenants, conditions, performances, and promises hereinafter contained, the parties mutually agree to amend the Interlocal Agreement as follows:

1. Section 3(f) of the Agreement is deleted in its entirety and replaced with:

f. Contract Maximum. Total charges under this Agreement, all fees and expenses included, shall not exceed \$300,000 for the initial term and first two year extension of this Agreement.

2. Section 7 of the Agreement is deleted in its entirety and replaced with:

4. Amendment 1, Schedule B, attached to this Amendment No. 1, is hereby incorporated by reference into the Agreement. The pricing contained in Amendment 1, Schedule B shall apply to work performed by the Contractor on or after December 1, 2024.
5. Pursuant to Section 2 of the Agreement the parties agree to extend the Agreement for the first additional two year term (December 1, 2024-November 30, 2026).
6. Except as expressly provided in this Amendment No. 1, all of the terms and conditions of the Agreement are ratified and affirmed and remain in full force and effect.
7. This Amendment No. 1 may be executed in counterparts, each of which shall constitute an original and all of which shall constitute one and the same agreement.
