Subject: U.S. Department of Housing and Urban Development Continuum of Care

(CoC) Program Grant Agreement for Renewal Projects

**Scope:** Proposed Motion 23-395 authorizes the Executive to execute a contract

with The U.S. Department of Housing and Urban Development (HUD) for

a grant totaling \$11,827,218.

The County will receive \$1,058,603 to operate 4 projects. The required match for these projects is \$264,652. Subrecipients will manage nineteen additional projects included in the CoC renewal grant and provide the required match for these projects. The total grant amount with match

included is \$14,763,588.

This project was included in the 2023 Human Services Department Grant Workplan in the amount of \$14,120,148<sup>1</sup>. The change in the total grant amount is greater than \$50,000 and requires Council consideration

pursuant to SCC 4.26.025<sup>2</sup>.
