BRIEF DESCRIPTION:

A competitive Invitation to Bid (ITB) was issued for disposal of Moderate Risk Waste, replacing the current awards previously competed under 076-16SB & 22-051JM. The County seeks to dispose of moderate risk waste, gathered from various sites in Snohomish County and packaged at the Snohomish County MRW Facility, to certified disposal facilities. This ITB establishes primary and secondary awards for each material type to firm to be used by the County for delivery. The bid term is to begin April 15, 2024, end on April 14, 2026, with option to extend for two (2) additional two-year terms. Total expenditure amount for Year One is projected to be \$350,000.00.
