Dear Ms. Gray:

As discussed, we are requesting an addendum for the Cathcart and McDougall vehicle hoists project. This addendum will cover additional work that was necessary through the design process to provide a plan with dimensions for the contractor for installation of the new concrete foundations in both buildings. In discussions with the contractor that will accomplish the work we now understand that we will need to be more involved in the construction administration than we had originally planned. Specifically, we will need to provide several site inspections during construction to review the epoxy doweling of rebar into the existing concrete slab floors. We will provide the reports for these inspections. We will need to work with the contractor on the mix design for the high early strength of the concrete to decrease the time the lifts are idle. Various other items will be addressed with Requests for Information from the contractor.

Task 1 Project Management:

Manage the CG team to respond to contactor questions and issues.

Task 2 - Construction Services:

We will provide structural consultation during the construction phase as requested by the County project manager.

- Respond to contractor questions (RFI's).
- Work with County personnel to schedule the project.
- Approve of contractor submittals and substitutions.

- CG will assist with the contractor communication during construction. The County will take the lead in requests for payment from the contractor.
- Site visits during construction are included with observation reports.
