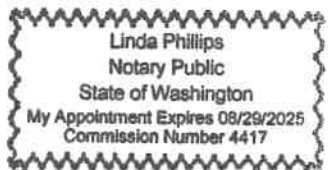

Drewel Building, 3000 Rockefeller, Everett, Washington, to consider proposed Ordinance No. 21-054, titled: RELATING TO THE GROWTH MANAGEMENT ACT, ADOPTING TECHNICAL AMENDMENTS TO THE SNOHOMISH COUNTY GROWTH MANAGEMENT ACT COMPREHENSIVE PLAN (GPP 21-3 - TECHNICAL CORRECTIONS)

**Background:** This ordinance is part of the County's annual county-initiated comprehensive plan amendment process authorized by RCW 36.70A.130 and by Snohomish County Code (SCC) 30.73.065. The ordinance adopts technical amendments to Maps 1, 2, 4 and 5 of the General Policy Plan (GPP), as described below. A summary of the proposed ordinance is as follows:

**PROPOSED ORDINANCE NO. 21-054**

**Sections 1 – 3.** Adopts recitals, findings of fact, and conclusions, and states that the Council bases its findings and conclusions on the entire record of the Planning Commission and the County Council.

**Section 4.** Adopts Exhibit A, amending Map 1 to reflect three city and town annexations that were finalized since the last county adoption of technical corrections to Map 1.

**Section 5.** Adopts Exhibit B, amending Map 2 to reflect three city and town annexations that were finalized since the last county adoption of technical corrections to Map 2.

**Section 6.** Adopts Exhibit C, amending Map 4 to reflect three city and town annexations that were finalized since the last county adoption of technical corrections to Map 4.

**Section 7.** Adopts Exhibit D, amending Map 5 to reflect three city annexation that was finalized since the last county adoption of technical corrections to Map 5.

**Section 8.** Directs the code reviser to update SCC 30.10.060 pursuant to SCC 1.02.020(3).

**Section 9.** Provides a standard severability and savings clause.

The County Council may continue the hearing to another date to allow additional public testimony thereafter, if deemed necessary. 

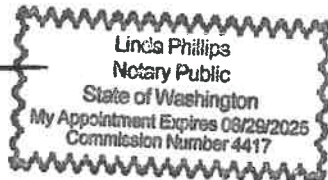

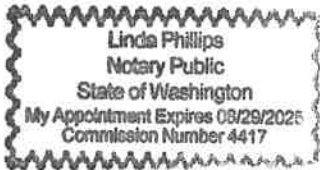
