PROPOSED ORDINANCE NO. 23-074

RELATING TO PURCHASING AND CONTRACTING; AMENDING CHAPTER 3.04 SNOHOMISH COUNTY CODE

Summary: The ordinance adopts amendments to Snohomish County's Purchasing Code Chapter 3.04 to be more in line with recent state code changes and industry best practices that would allow the County to operate faster, more efficiently, and to remove outdated language. A summary is as follows:

Section 1. SCC 3.04.005 is amended relating to definitions for "Bidding" and "County official".

Section 2. SCC 3.04.015 is amended relating to exemptions for subawards, interlocal and intergovernmental agreements for services, contracts funded by federal, state, or private grants.

Section 3. SCC 3.04.030 is amended to clarify the role of the Purchasing Manager.

Section 4. SCC 3.04.060 is amended to include that the Purchasing Manager shall prepare reports as required by the Executive.

Section 5. SCC 3.04.075 is repealed.

Section 6. SCC 3.04.090 is amended relating to standardization by deleting language in parts of subsection (1) and entirely delete subsections (2), (3), and (4).

Sections 7 and 8. SCC 3.04.100 and 3.04.110 are repealed.

Section 9. SCC 3.04.120 is amended to delete reference bid requirements and clarifies the process for formal sealed bidding.

Section 10. SCC 3.04.130 is repealed.

Section 11. SCC 3.04.135 is amended to increase the threshold costs for small works roster processes and allow the county to exercise its discretion to use competitive thresholds.

Section 12. SCC 3.04.140 is amended relating to contract award thresholds, execution process, and approval authority.

Section 13. SCC 3.04.160 is amended relating to purchases, leases, and contracts for personal property, supplies, materials, and equipment.

Section 14. SCC 3.04.175 is amended to provide that all public works contracts be advertised and competed through formal sealed bidding, except as otherwise provided by this chapter or state law.

Section 15. SCC 3.04.180 is amended to clarify proprietary purchases and the requirements for advertisement and solicitation.

Section 16. SCC 3.04.190 is repealed.

Section 17. SCC 3.04.195 is amended relating to awards of A/E contracts.

Section 18. SCC 3.04.200 is amended relating to contract approval by the Council or County Executive in the event of emergencies.

Section 19. A new section is added to read SCC 3.04.201 Services other than architectural and engineering and public work.

Section 20. A new section is added to read SCC 3.04.202 Services for which competition is waived.

Section 21. A new section is added to read SCC 3.04.203 Services for which competition is waivable.
