# POLICY COUNCIL LEADERSHIP TIMELINE

- Recommend electing new chair each August effective September
  - o Chair positions are from September 2024 through August 2025
- Recruit member and alternate from each ITS area
  - ITS are working hard to recruit new Policy Council members
  - The goal is to have one member and one alternate for each ITS area

# FULL ENROLLMENT INITIATIVE - Fully enrolled by December 31, 2024

- Explanation of how enrollment reports are calculated
  - EHS needs to be fully enrolled for 6 months
  - Each month Kristina will run reports on how many children attended at least one day
- Current Enrollment
  - Current enrollment as of end of prior month
    - March reported 81 attended
    - Currently at 77, exited 4, 81 will be reported for April
  - Anticipated exits for remainder of year
    - Kristina will be tracking the number of children each month
  - Current waitlist
    - Currently we have 5 on the waiting list
    - Once the ITS position is filled, we will be full again

# FIVE YEAR APPLICATION TIMELINE - Due at the end of September

- School Readiness Goals- Consultant and Kristina have drafted them for new application.
- Strategic Planning The end of June
  - The hired consultant would be leading this process

- We would like to have Policy Council and 1 person for each ITS area involved in this process
- Kristina asked the Policy Council if they would prefer a 6 hour in-person session or 2, 3 hour zoom sessions
  - Janelle prefers in-person
  - Feliciana prefers zoom
  - Kristina will get opinions of others and get back to the Policy Council
- Program Evaluation- families will complete surveys and staff will do program selfevaluation.
- Approval Process
  - Policy Council will be part of the approval process by the end of August

### MANAGEMENT REPORT

- Program Updates
  - Parent survey was completed at the beginning of Spring quarter
    - Topics of interest: CPR, eating on a budget, community resources, participation in the garden
    - May and June are planned to include those topics
    - CPR has been completed
  - o The socialization calendar is up to date and has zoom links included
- Staffing Updates
  - Mental Health Consultant position has been posted since September with no successful candidates
  - We are contracting with an outside person for 10 hours per month
    - This position covers 25% of EHS and 75% of ECEAP
  - Potential opening for ITS position later this Spring
- Steppingstones Event June 8<sup>th</sup> at Health District from 10:00 AM to 2:00 PM
  - Partnering with Health District and ESIT
  - Focus is on good health and employment
  - College ESL represent and BFET
  - Clothing and supply swap
    - Would like to have PC parents take the lead of the clothing drive
    - Designed for children 5 and under
  - The Health Department is offering FREE Lead Testing
    - There will be a reminder from area ITS staff to bring items to be tested
