**Subject:** Interlocal Agreement with the city of Arlington for Information Technology Services.

**Scope:** This agreement would allow the Snohomish County Department of Information Technology (SCIT) to provide technology services to the city of Arlington, including services via supplemental Work Orders (WO) based on the current year approved IT rate model and established contract pricing.

**Authority Granted:** Approves and authorizes the County Executive to execute an Interlocal Agreement for information technology services, and corresponding Work Orders and amendments between Snohomish County and the city of Arlington, under RCW 39.34 and SCC 3.04.210 and 3.01.140(11).

**Background:** Snohomish County Information Technology has leveraged the County's existing technology infrastructure and expertise to provide services to the city of Arlington since 2015. The city of Arlington wishes to continue to receive services from the County. The proposed agreement includes the terms and conditions of the agreement. Each WO will include a description of the specific services, terms and cost from the published rate or fee schedule. The scope of information technology goods and information services to be provided are limited to the following:

- Network Equipment Hosting 2-Rack unit space.
- Provide cross-connections to connect to other agencies or services located in the SCIT data center.
- Network Service Administration.
- GIS Services.
- Imagery Data 3" AccuPlus.
- Imagery Data 9" AccuPlus.
- Imagery Data Administrative Services
