It was a consensus of the Council to move Motion No. 22-410 to the Council's Special Meeting Thursday, September 29th at 1:00 p.m. for consideration.

Surface Water Service Charge for Invasive Aquatic Plant
Management on Lake Roesiger, clarifying the Title of SCC
25.20.050 and repealing SCC 25.20.060

Nicole Gorle, Sr. Legislative Analyst, provided a staff report and explained the need for a funding source to manage invasive plants on Lake Roesiger. She said this ordinance would add a surface water service charge to the county code for aquatic invasive species management on Lake Roesiger in effect for five years. She explained that funds would be dedicated to Lake Roesiger and could not be used for any other purpose. After five years, it would need to be reenacted by Council. She, briefly, spoke, about outreach and public hearing notice to the community.

Councilmember Low thanked our staff and especially to Marisa (Burghdoff) on the Executive's side for her work with the community the last couple of years. Councilmember Low noted that the hearing is being pushed out to October 26th to allow time for everyone to have a voice.

Councilmember Nehring also thanked staff. He asked about the alternatives if the surcharge is not placed on the lakefront owners and asked if it would be charged countywide. Marisa Burghdoff, Surface Water Management (SWM), responded and explained that SWM's plan is to not pursue if the ordinance does not pass. She said the community could establish a Lake Management District through state regulations, which would also go through Council. Councilmember Nehring asked if there were any other alternatives. Ms. Burghdoff said SWM would not take additional action on the plan without support from the community.

Councilmember Low added that part of this process is that the County will apply for one or more grants. Ms. Burghdoff confirmed that was correct and said they will be applying for a grant this fall with the Department of Ecology.
