PROPOSED ORDINANCE NO. 23-082

RELATED TO THE 2023 BUDGET;
MAKING A SUPPLEMENTAL APPROPRIATION IN GENERAL FUND 002
TO PROVIDE EXPENDITURE AUTHORITY FOR FUNDS RECEIVED FROM THE
WASHINGTON STATE ADMINISTRATIVE OFFICE OF THE COURTS

Summary: The ordinance makes a supplemental appropriation in the amount of \$160,000 for funds received from the Washington State Administrative Office of the Courts for the reimbursement of court ordered refunds of Legal Financial Obligations (“LFOs”) for eligible persons seeking to vacate felony convictions and/or to be re-sentenced pursuant to *State v. Blake* decision.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
