NOTICE OF ENACTMENT

NOTICE IS HEREBY GIVEN, that on January 12, 2022, the Snohomish County Council approved Ordinance 21-101, which shall be effective February 3, 2022. A summary is as follows:

ORDINANCE NO. 21-101

RELATED TO THE 2022 BUDGET; MAKING A SUPPLEMENTAL APPROPRIATION IN FUND 130 TO PROVIDE ADDITIONAL EXPENDITURE AUTHORITY TO THE DEPARTMENT OF EMERGENCY MANAGEMENT FOR COVID-19 VACCINATION EFFORTS

Section 1. The County Council makes the following findings of fact: a supplemental appropriation in the amount of \$2,500,000 is necessary in Fund 130, for budget year 2022, to provide additional expenditure authority for FEMA Public Assistance grant funding received from DOH and SHD.
