Mr. Martin explained that hours would effectively be a reimbursement into their leave bank. Chair Wright responded to Vice-Chair Dunn regarding the increase from two to four hours in leave in the substitute ordinance. Vice-Chair Dunn provided supportive comments.

ACTION: Vice-Chair Dunn made a motion to approve Substitute Ordinance 21-050. Councilmember Mead seconded the motion.

Chair Wright opened the hearing for public testimony. There being no persons present wishing to testify, she closed the testimony portion of the hearing.
