At Microsoft, I helped design and implement programs that brought music tech summer camps to underserved neighborhoods, hosted STEAM-focused youth events incorporating projects like 3D art and music production, and built funding pipelines for minority-led arts exhibitions. I've also volunteered locally through my church, performing and supporting musical events. These experiences have reinforced my belief that access, visibility, and support are essential for artists to thrive — and I would bring that lens to every initiative I support as a commissioner.

Do you have a vision to mobilize creative expression in Snohomish County?

Yes. I envision an arts community where every resident, regardless of background or location, can easily discover and connect with the arts — both in person and online. I believe Snohomish County has the potential to become known for its vibrant arts culture, similar to how cities like Austin or Chicago have woven the arts into their civic identity. I'd love to help the commission grow programs that promote artists through social media, digital storytelling, and cross-platform engagement, making the arts more visible and accessible to everyone.

What areas of arts advocacy will you focus on as a commissioner?

I'm especially passionate about supporting emerging artists, increasing public access to the arts, and creating pathways for creative youth to engage in meaningful expression. As someone who spent much of my professional career navigating the industry as an emerging artist, I understand the challenges new artists face and how transformative it can be when they are supported and celebrated by their community. I'm also committed to helping the county expand access in underrepresented and rural areas, where resources and exposure can be limited.
