

AMENDMENT 6 TO THE SOFTWARE AS A SERVICE (SAAS) AGREEMENT

This Amendment 6 to the "Software as a Service (SaaS) Agreement for Emergency Response Notification Services" (the "Original Agreement"), executed on February 12, 2020, as amended by Amendment 1 dated October 25, 2021, Amendment 2 dated January 18, 2023, Amendment 3 dated September 14, 2023, Amendment 4 dated January 24, 2024, and Amendment 5 dated November 7, 2024 (together, hereafter the "Agreement"), by and between Snohomish County, a political subdivision of the State of Washington (the "County") and Rave Wireless, Inc. dba Rave Mobile Safety, duly registered and authorized to conduct business in Washington State (the "Contractor") is made and entered to become effective upon mutual execution of the parties.

RECITALS

WHEREAS, the County's Agreement with the Contractor includes a provision to provide the services to other cities or agencies; and

WHEREAS, the City of Marysville (Marysville) currently receives alert services directly from the Contractor; and

WHEREAS, beginning January 1, 2026, pursuant to its authority under SCC 2.350.030(6), the County intends to provide Marysville alert services through its Agreement with Contractor; and

WHEREAS, the County does not intend to pay any costs associated with the migration of Marysville data into the County's platform nor any costs related to Marysville's own operational messaging number; and

WHEREAS, the increased cost to the County for providing alert services to Marysville through its Agreement with Contractor is Four Thousand Eight Hundred Eighty Dollars (\$4,880.00) annually.

NOW, THEREFORE, in consideration of the mutual obligations set out below, the parties agree that the Agreement is amended as follows:

1. Exhibit A-4, Ordering Document for alert services for Marysville beginning January 1, 2026 through February 11, 2026, is attached hereto and hereby is added to the Agreement.
2. Exhibit A-5, Customer Order Form for alert services for Marysville beginning February 12, 2026 through February 11, 2027 is attached hereto and hereby is added to the Agreement.
3. Section VII, Price and Payment, Subsection A is deleted in its entirety and replaced with the following:

VII. Price and Payment.

A.1 The County shall pay the Contractor Ninety-One Thousand Seven Hundred Thirty-Two Dollars (\$91,732.00) for the Deliverables required to be provided by the Contractor as described in Exhibit A. Order Form and Statement of Work. Annual recurring charges for Software Subscription Services in years two (2) through five (5) shall not exceed Eighty-Seven Thousand Nine Hundred Thirty-Two Dollars (\$87,932.00) per year or a total of Four Hundred Thirty-Nine Thousand Six Hundred Sixty Dollars (\$439,660.00).

A.2 Beginning with year six (6), there shall be an annual renewal increase of two (2) percent on the Anniversary Date.

A.3 Beginning January 1, 2027, there shall be an annual increase of \$4,880.00 for alert services for Marysville.

- 3.** All other terms and conditions of the Agreement shall remain in full force and effect except as expressly modified by this Amendment 6.

IN WITNESS WHEREOF, the parties hereto have executed this Amendment 6 to become effective upon mutual execution of the parties.

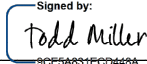
