APPROVING AGREEMENT WITH THE STATE OF  
WASHINGTON DEPARTMENT OF ECOLOGY FOR WELLSITE  
INSPECTIONS

Summary: The County enters into an agreement with the State of Washington Department of Ecology to provide delegation and funds to Snohomish County to administer and enforce the well sealing, tagging, and decommissioning apertions of the water well construction regulations.

At the hearing, Council may consider alternatives/amendments to the proposed ordinance.

Public Testimony: All interested persons may testify at the time and place indicated above or by remote participation. The chair of the council may choose to limit testimony to three minutes in the interest of accommodating all persons wishing to testify.
