## AMENDED MOTION NO. 24-420

## CONCERNING AMENDMENTS TO THE NORTH SNOHOMISH COUNTY COORDINATED WATER SYSTEM PLAN

WHEREAS, the North Snohomish County Coordinated Water System Plan (CWSP) was initially approved by the Washington State Department of Health (DOH) on February 21, 1992; and

WHEREAS, Chapter 70A.100.050 RCW - Public Water System Coordination Act of 1977, requires that the DOH ensure that such plans are reviewed by local governments to insure that such plans are consistent with local land use plans, shoreline master programs, and/or developmental policies; and

WHEREAS, periodic revisions to the CWSP are appropriate and have been made to ensure that the CWSP adequately addresses emerging issues and changes in plans, policies, and regulations; and

WHEREAS, the North Snohomish County Water Utility Coordinating Committee (WUCC), in its advisory role under Chapter 70A.100.040 RCW, has recommended changes to the CWSP in the following general categories: update obsolete information, perform a consistency check with regulations and new or revised policy directions; and

WHEREAS, WUCC members including representatives from DOH, and Snohomish County Health Department proposed revisions to the Coordinated Water System Plan; and

WHEREAS, the Snohomish County Planning Commission, on behalf of the WUCC, conducted public meetings allowing for review and comment from the public on the proposed revisions to the CWSP; and

WHEREAS, Planning and Development Services (PDS) staff has reviewed the proposed revisions to the CWSP and found them to be with consistent with Snohomish County's land use plans, shoreline master program, and development policies; and

WHEREAS, the County Council conducted a public hearing on December 4, 2024, as required by RCW 70A.100.050(7); and

WHEREAS, the County Council intends to provide a recommendation concerning whether the DOH should approve the proposed amendments to the CWSP pursuant to Chapter 70A.100.050 RCW;

NOW, THEREFORE, ON MOTION:

A. The County Council finds that the revised plan is consistent with local land use plans, shoreline master program, and development policies, and contains the required elements as described in RCW 70A.100.050(4).

B. The County Council finds that the North Snohomish County Coordinated Water System Plan should be revised consistent with the proposed draft CWSP – July 2024, and revised CWSP map.

C. The County Council authorizes PDS to transmit the proposed amendments to the CWSP to the DOH for approval following conclusion of the public hearing required by RCW 70A.100.050(7).
