APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO SIGN THE INTERLOCAL AGREEMENT BETWEEN SNOHOMISH COUNTY AND SNOHOMISH CONSERVATION DISTRICT FOR THE SKYKOMISH RIPARIAN AGROFORESTRY FEASIBILITY, SWANS TRAIL SLOUGH, AND COMMUNITY ENGAGEMENT, OUTREACH AND EDUCATION PROJECTS IN THE STILLAGUAMISH BASIN

<u>Summary:</u> The ordinance approves the agreement to allow for the National Oceanic and Atmospheric Administration (NOAA) Habitat Conservation Grant funds in the amount of \$725,000.00 to pass to the Snohomish Conservation District. The grant funds are part of the Washington Department of Fish and Wildlife's awarded portion of the NOAA Grant, of which the District is a sub-awardee. The duration of the agreement is from execution through April 30, 2027.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
