Public Works Initiatives

- CARES funds
 - ~\$500k for staff reimbursement (DEM support) and PPE/equipment for operations to prevent the spread of COVID
- ARPA funds none requested or allocated to-date
- PW hybrid workforce:
 - ~85% office staff working remotely
 - Operations and field staff fully operable with health and safety plans
 - Traffic permitting counter open to public since July
 - Records cleanup, space improvements and consolidation
- Technology: Kronos, Cartegraph, See-Click-Fix, and Open Text
- Facilities projects:
 - Arlington Operations Center and Granite Falls property
- PW DEI Plan implementation
- New legislation does not directly impact budgets




Staffing Changes (FTEs) – Road Fund

- Permanent Staffing
 - o No new FTEs in 2021
 - o Five new FTEs in 2022
- Temporary/Seasonal
 - 2022 status quo (~100 seasonal RM workers)
- All positions are funded in 2022 budget
- Ongoing vacancies range between 40 60




Solid Waste Management (142 FTEs)

Solid Waste, in coordination with many service providers, oversees county programs and facilities for the proper management of garbage, recycling and household hazardous waste.

2022 budget is 15% more tonnage than prior 2007 peak, with similar staffing levels

- 2022 inbound system tonnage estimated at 586,299 (3.7% growth from 2021 budget)
- 2022 RRW tonnage estimated at 84,000 (110% growth from 2021 budget)
- 2022 vactor loads estimated at 6,000 (71% growth from 2021 budget)
