

Dear Members of the Snohomish County Council,

It is my great honor to provide this letter recommending Chief Criminal Deputy Matthew Baldock for appointment to the Snohomish County South District Superior Court bench.

In January of 2012 I sought help, disclosing a very vulnerable part of my life: My father sexually assaulted me for several years. Shortly thereafter, I met Matt Baldock as the prosecutor assigned to my case. I was a very vulnerable and emotionally unstable 16-year-old girl. Over the next 18 months, Mr. Baldock devoted hours to my family, absorbing every ugly detail so that justice could be served. During my testimony sharing the details of my abuse in front of my offender and a jury full of strangers, Mr. Baldock remained patient and collected in the courtroom. He remained neutrally tempered in the courtroom during outbursts of my emotion and angst. After first and second trials concluded in hung juries, Mr. Baldock supported me and pursued a successful third trial to achieve justice.

What I appreciate most about Mr. Baldock is his dedication for seeking justice for victims, and his efforts to support and encourage women in particular, as they grow into Survivors. Mr. Baldock has helped many victims since he helped me. In particular, I had a former teammate of mine reach out to me and open up regarding sexual abuse she had also endured. We were not only bonded through our love for basketball but we had experienced similar abusive behavior from a trusted family member. We also discovered that we had the same Prosecutor who fought for us in our pursuit for justice, Mr. Baldock.

As I finished high school and transitioned to my professional career, Mr. Baldock became a mentor for me as I witnessed his continued dedicated service to victims seeking justice. His leadership among his peers is contagious and transfers to the courtroom for his victims. He instills a spirit of hope in those he helps. His devotion inspired me to want to be a public servant in a similar capacity. As a female Police Officer now, I can confidently say I would not be in these boots today if it weren't for Mr. Baldock's compassion for victims in getting justice, recovering, and becoming that Survivor.

Mr. Baldock has paved the road for many victims and will continue to do so in any capacity that he can. I truly cannot think of anyone more suitable for this honorable and trusted position. Please contact me if you have any questions.
